Should the work authorized under a conditional use permit fail to commence within one hundred and eighty (180) days of the issuance of the permit, it shall be conclusively presumed that the Applicant has waived, withdrawn, or abandoned said permit and all such permits shall be deemed automatically rescinded by the Borough Council.
All applications for conditional use shall be submitted to the Lewisburg Borough Planning Commission for their review and recommendation.
Additional information required by the Borough Council will accompany this application for hearing.
